percy at the close of his copy of sir patrick spence tells us that an ingenious friend of his was of opinion that the author of hardyknote has borrowed several expressions and sentiments from the foregoing ballad and other old scottish songs in this collection it does not seem to have ever occurred to the learned editor or any friend of his however ingenious that perhapssir patrick spence had no superior antiquity over hardyknote and that the parity he remarked in the expressions was simply owing to the two ballads being the production of one mind neither did any such suspicion occur to scott he fully accepted sir patrick spence as a historical narration judging it to refer most probably to an otherwise unrecorded embassy to bring home
