ETHICS THEORY A FOUNDATION FOR UNDERSTANDING BEFORE TACKLING THE COMPLEX CONTEMPORARY ISSUES LET'S BRIEFLY EXPLORE SOME FOUNDATIONAL ETHICAL THEORIES

CONSEQUENTIALISM THIS THEORY EMPHASIZES THE OUTCOMES OF ACTIONS THE BEST ACTION IS THE ONE THAT MAXIMIZES GOOD CONSEQUENCES AND MINIMIZES BAD ONES

UTILITARIANISM A PROMINENT CONSEQUENTIALIST THEORY JUDGES ACTIONS BASED ON THEIR OVERALL HAPPINESS FOR THE GREATEST NUMBER OF PEOPLE

EXAMPLE A GOVERNMENT DECIDING WHETHER TO ALLOCATE RESOURCES TO FLOOD RELIEF IN ONE AREA VERSUS ANOTHER MIGHT USE A UTILITARIAN FRAMEWORK TO ASSESS THE IMPACT ON THE OVERALL HAPPINESS OF CITIZENS CONSIDERING FACTORS LIKE POPULATION DENSITY INFRASTRUCTURE VULNERABILITY AND POTENTIAL LOSS OF LIFE

DEONTOLOGY IN CONTRAST TO CONSEQUENTIALISM DEONTOLOGY FOCUSES ON THE INHERENT RIGHTNESS OR WRONGNESS OF ACTIONS REGARDLESS OF THEIR CONSEQUENCES RULES AND DUTIES OFTEN STEMMING FROM MORAL PRINCIPLES OR RELIGIOUS BELIEFS TAKE PRECEDENCE

EXAMPLE A DOCTOR SWORN TO THE HIPPOCRATIC OATH HAS A DUTY TO PRESERVE LIFE REGARDLESS OF THE POTENTIAL PERSONAL COST

VIRTUE ETHICS THIS APPROACH EMPHASIZES THE CHARACTER OF THE INDIVIDUAL MAKING THE DECISION MORAL ACTIONS STEM FROM VIRTUOUS CHARACTER TRAITS LIKE HONESTY COMPASSION AND COURAGE

EXAMPLE A JOURNALIST STRIVING FOR TRUTHFULNESS IMPARTIALITY AND INTEGRITY IN THEIR REPORTING EMBODIES VIRTUOUS ETHICAL BEHAVIOR

ARTIFICIAL INTELLIGENCE AND ROBOTICS AUTONOMOUS WEAPONS SYSTEMS

THE DEVELOPMENT OF AI-POWERED WEAPONS CAPABLE OF SELECTING AND ENGAGING TARGETS WITHOUT HUMAN INTERVENTION RAISES PROFOUND ETHICAL QUESTIONS REGARDING ACCOUNTABILITY AND POTENTIAL FOR UNINTENDED ESCALATION

CASE STUDY THE USE OF AUTONOMOUS DRONES IN TARGETED KILLINGS AND THE LACK OF HUMAN OVERSIGHT IN DETERMINING THE TARGETS GENERATES INTENSE DEBATE ABOUT RESPONSIBILITY
