2. PROPER USE OF PUNCTUATION PUNCTUATION GUIDES THE READER THROUGH YOUR LEGAL REASONING. - COMMA (,): SEPARATES ELEMENTS IN A LIST, AFTER INTRODUCTORY WORDS, OR SET OFF NON-ESSENTIAL INFORMATION.
