how the redefinition of antisemitism has functioned as a tactic to undermine palestine solidarity the widespread adoption of the ihra definition of anti semitism and the internalisation of its norms has set in motion a simplistic definitional logic for dealing with social problems that has impoverished discussions of racism and prejudice more generally across britain and beyond it has encouraged a focus on words over substance erasing palestine tells the story of how this has happened with a focus on internal politics within britain over the course of the past several years in order to do so it tells a much longer story about the history of antisemitism since the beginning of the twentieth century this is also a story about palestine a chronicle of the erasure of the violence against the palestinian people and a story about free speech and why it matters to palestinian freedom

this book uses the methodology of sociology and literary studies to come to terms with the reality of palestinian citizens of israel across several generations it explores the evolution of palestinian identity from one that struggled for independence and self determination up to 1948 to one that now presses the call for civil rights and civic equality what were the forces that shaped this transformation over six decades a traditional sociological research on this community focusses on the structural relationships between israel and its palestinian citizens primarily concerned with the political discourse and activism of this community it mostly makes use of party agendas voting patterns and opinion polls as primary indicators in contrast this book focuses on the palestinian voice through an analysis of the 75 novels published by palestinian citizens of israel from 1948 to 2010 paying attention to processes that are internal to this community the author identifies the intellectual and ideological forces that drove major social and political transformations in this community over this period

writing about palestine and the palestinians continue to be controversial until the late 1980s the question of palestine was approached through western social theories that had appeared after world war 2 this endowed european settlers and colonists the mission of guiding the backward natives of palestine to modernity however since the work of palestinian scholar elia zureik the study of israel and the ethnic relations in palestine israel has been radically shifted building on

zureik s work this book studies the colonial project in palestine and how it has transformed palestinians lives zureik had argued that israel was the product of a colonization process and so should be studied through the same concepts and theorization as south africa rhodesia australia and other colonial societies he also rejected the moral and civilizational superiority of the european settlers developing this work the contributors here argue that colonialism is not only a political economic system but also a mode of life and consciousness which has far reaching consequences for both the settlers and the indigenous population across 13 chapters in addition to the introduction and the afterward the book covers topics such as settler colonialism dispossession the separation wall surveillance technologies decolonisation methodologies and popular resistance composed mostly of palestinian scholars and scholars of palestinian heritage it is the first book in which the indigenous palestinians not merely write back but principally aim to lay the foundations for decolonial social science research on palestine

2012 marks the 63rd anniversary of the nakba the most traumatic catastrophe that ever befell palestinians this book explores new ways of remembering and commemorating the nakba in the context of palestinian oral history it explores social history from below subaltern narratives of memory and the formation of collective identity masalha argues that to write more truthfully about the nakba is not just to practise a professional historiography but an ethical imperative the struggles of ordinary refugees to recover and publicly assert the truth about the nakba is a vital way of protecting their rights and keeping the hope for peace with justice alive this book is essential for understanding the place of the palestine nakba at the heart of the israel palestine conflict and the vital role of memory in narratives of truth and reconciliation

a comparative study of contemporary israeli and palestinian diasporas exilic and diasporic experience have become ubiquitous in recent decades jews lacking a homeland spread to various parts of the world making the jewish diaspora paradigmatic but after the establishment of israel in 1948 a different kind of diaspora emerged as more than a tenth of israeli citizens have chosen to leave their newly established state and resettle meanwhile about half of all palestinians including palestinian citizens of israel now reside in exile predominantly as a result of the ongoing palestinian israeli conflict recognizing that israeli jewish and palestinian arab societies coexist and are engaged in constant relations nahum karlinsky has assembled an impressive array of contributors to explore these diasporas alongside one another and in dialogue with other diasporic communities the collected essays cover such topics as palestinian exiles and diasporas the demographics of today s israeli diaspora immigrant enterprises transnationalism and development the unique place of israeli jews in the united states the literature of palestinian transnationals and the emergence of berlin as a queer israeli jewish immigrant enclave the modern israeli and palestinian diasporas challenges and reimagines the very notion of a homeland

this interdisciplinary book provides timely fresh perspective on palestine israel by rethinking the nature of settler colonial sovereignty and the relationship between land and people muhannad ayyash argues that this relationship comes in two distinct forms a settler colonial type practiced by the israeli state that consists of lordship over land and people and a decolonial type seen in palestinian popular organizing that he calls land as life a reciprocal bond the former is characterized by private ownership possession and violent expulsion of others the latter by communal ownership belonging to the land and opposition to the violence of expulsion ranging widely across theory and history ayyash contends that the opposition between these two types is at the core of the palestinian israeli struggle the choice before us today he concludes is between the continuation of the israeli settler colonial project in particular and the project of colonial modernity in general or the commencement of a decolonial age in palestine israel and beyond offering both novel theorizations and politically engaged analysis lordship and liberation in palestine israel illuminates how decolonial sovereignties represent an alternative to settler colonial violence

though the current political situation in palestine is more serious than ever contemporary palestinian art and film is becoming paradoxically increasingly funny in laughter in occupied palestine chrisoula lionis analyses both the impetus behind this shift toward laughter and its consequences arguing that laughter comes as a response to political uncertainty and the decline in nationalist hope revealing the crucial role of laughter in responding to the failure of the peace process and ongoing occupation she unearths the potential of humour to facilitate understanding and empathy in a time of division this is the first book to provide a combined

overview of palestinian art and film showing the ways in which both art forms have developed in response to critical moments in palestinian history over the last century these key moments lionis argues have radically transformed contemporary palestinian collective identity and in turn palestinian cultural output mapping these critical junctions beginning with the balfour declaration of 1917 to the oslo accords in 1993 she explores the historical trajectory of palestinian art and film and explains how to the failure of the peace process has led to the present proliferation of humour in palestinian visual culture

the ongoing devastation in gaza and other parts of palestine alongside the systematic destruction of palestinian universities has coincided with intensified censorship and repression within western academic institutions these developments reveal the distinctive position that zionism and its defense has held for decades within western imperial structures creating patterns of epistemic injustice palestine and the western academe emerges from a collective sense of political and intellectual urgency in response to mounting repression against scholars and students working on and studying palestine while attacks on academic freedom and freedom of speech in western academia have intensified they have been met with new forms of resistance and disobedience bolstered by coalitional anti-racist and anti-capitalist solidarities extending from palestine globally this edited volume brings together significant contributions from scholars and students offering fresh approaches to the epistemic and political struggles surrounding palestine it demonstrates the timely and enduring relevance of the palestinian question to international academic spaces and is essential reading for academics researchers and students interested in middle eastern studies political science international relations critical theory decolonial studies and academic freedom discourse most of the chapters in this book were originally published in middle east critique this edition comes with several new chapters and an updated introduction offering fresh perspectives and expanded analysis on these urgent and evolving issues

in his book on social closure jürgen mackert seeks to reinvigorate the idea of social closure and bring it back as a basic sociological concept for understanding the strategies and processes powerful groups use to improve their life chances at the expense of the less powerful to do this he puts forward a mechanism based explanatory approach that makes it possible to empirically study social closure through exclusion in the context of neoliberalism exploitation within global capitalism and elimination in the ongoing legacy of settler colonialism further he identifies two critical social mechanisms to explain how human beings are denied access to resources rights or critical networks and to bring power dynamics into closure analysis
